Newest Ultraman Movie, "Mega Monster Battle: Ultra Galaxy Legend: The Movie" Set for Release

- First New Ultraman Movie to be Distributed by Warner Bros. -

Tsuburaya Productions Co. Ltd. TYO Inc.

Tsuburaya Productions Co. Ltd. ("Tsuburaya Productions;" Head office: Setagaya-ku, Tokyo; President & CEO: Shinichi Ooka) will release "Mega Monster Battle: Ultra Galaxy Legend: The Movie" ("Daikaiju Battle Ultra Ginga Densetsu: The Movie") nationwide in Japan on December 12, 2009 (Saturday). This is the first new movie in the Ultraman series since the Tsuburaya Productions became part of the TYO Group in 2007.

As part of its medium- to long-term "multi-brand" strategy, TYO Inc. (Head office: Shinagawa-ku, Tokyo; President & CEO: Hiroaki Yoshida) took Tsuburaya Productions under its wing as a member of the TYO Group in October 2007. Since then, TYO has been working to restructure the company and develop new content businesses. In January 2008, TYO Inc. transferred a 33.4% stake in Tsuburaya Productions to the Bandai Group. Through Tsuburaya Productions, the TYO Group has formed an equity and business alliance with the Bandai Namco Group in order to build a framework for cooperation.

"Mega Monster Battle: Ultra Galaxy Legend: The Movie" was produced by a consortium that includes Tsuburaya Productions, Bandai, Bandai Visual, Namco Bandai Games, Warner Bros., Dentsu, Dentsu Tec, Shogakukan, dwango, and TYO. Tsuburaya Productions Vice President Junya Okabe spearheaded the film as its producer/visuals advisor, and it was directed by Koichi Sakamoto, who has worked previously in the US and New Zealand. This is Sakamoto's first film in Japan, and he has created a groundbreaking movie and brought to life the Ultraman World on a new scale. This is the first Ultraman movie to be distributed by Warner Bros. It aims to promote Ultraman internationally in the future.
